

# PIMCO Investment Grade Credit Fund (Canada)

## Seeks attractive returns from high quality corporate bonds

Combining PIMCO's forward-looking macroeconomic outlook and extensive bottom-up credit research, the fund helps investors take advantage of opportunities in higher-quality corporate bonds.

- **Attractive total return potential** The fund aims to provide investors with greater income potential relative to Treasuries and cash, as well as more income and less volatility in returns when compared to equity indexes.
- **Flexibility to enhance returns** The fund has the ability to broadly diversify across industries, issuers and regions of the corporate bond sector and can seek to add value through investments in high quality U.S. government bonds, mortgage related securities and foreign bonds.
- **Extensive credit resources and research** Employing a disciplined approach to credit research, the fund accesses PIMCO's team of more than 50 bottom-up credit investment professionals and utilizes top-down, bottom-up and valuation screens to identify what we believe are the most attractive opportunities in global credit markets.

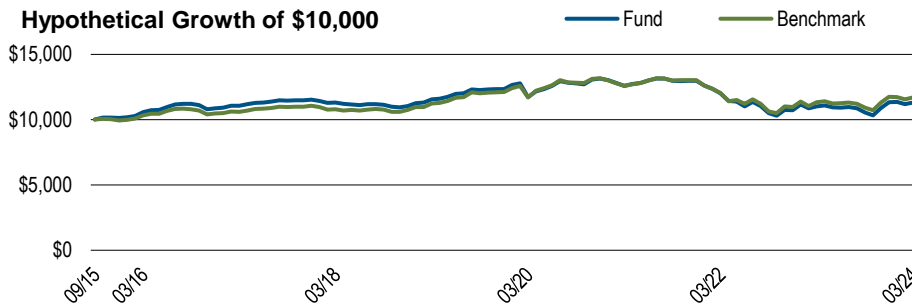
