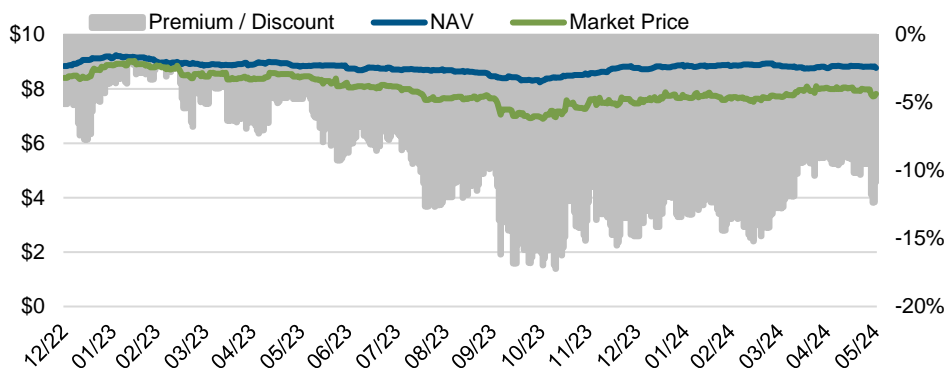

Total net asset value (NAV) return measures the change in NAV per unit over the period indicated. Distributions are assumed, for purposes of these calculations, to be reinvested at prices obtained under the Fund's distribution-reinvestment plan. As with any stock, the price of the funds common shares will fluctuate with market conditions and other factors.
