

This document contains key information you should know about Series A of PIMCO Diversified Multi-Asset Fund (Canada). You can find more detailed information in the fund's simplified prospectus. Before you invest in any fund, consider how the fund would work with your other investments and your tolerance for risk.

The fund is an alternative mutual fund. It is permitted to invest in asset classes or use investment strategies that are not permitted for other types of mutual funds. The specific strategies that differentiate the fund from other types of mutual funds include: increased use of derivatives for hedging and non-hedging purposes; increased ability to sell securities short; and the ability to borrow cash to use for investment purposes. While these strategies will be used in accordance with the fund's investment objectives and strategies, during certain market conditions they may accelerate the pace at which your investment decreases in value.

What does the fund invest in?

The fund primarily invests in equity and equity-related securities, fixed income instruments, currencies, commodity-related instruments and property-related instruments. The fund intends to use leverage. The leverage may be created through the use of derivatives, cash borrowings and short sales. The fund's leverage must not exceed three times the fund's net asset value. The leverage will be calculated in accordance with the methodology prescribed by securities laws, or any exemptions therefrom.

How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with a higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

PIMCO Canada Corp. has rated the volatility of this fund as **low to medium**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

No guarantees

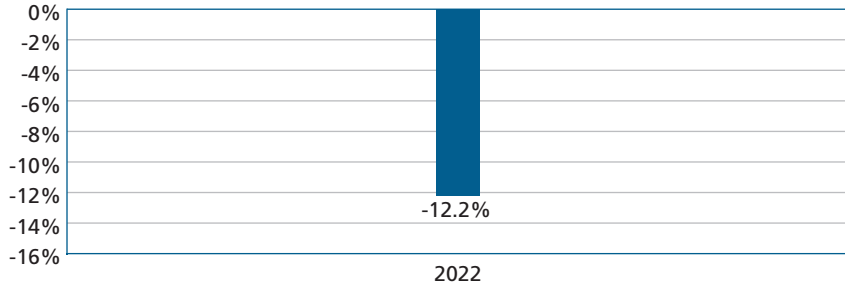
Like most mutual funds, this fund doesn't have any guarantees. You may not get back the money you invest.

How has the fund performed?

This section tells you how Series A units of the fund have performed over the past calendar year. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

Year-by-year returns

This section tells you how the Series A units of the fund have performed over the past calendar year. The fund dropped in value over the calendar year. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for the Series A units of the fund in a 3-month period over the past calendar year. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

As at April 30, 2023, a person who invested \$1,000 in Series A of the fund since the inception date now has \$879.07. This works out to an annual compounded return of -7.14%.

Who is the fund for?

Investors who:

- are looking for a diversified multi-asset fund
- are seeking medium-to-long term total return
- can accept the risk and volatility of a portfolio investing predominantly in and allocating dynamically across global equity and fixed income markets
- invest through dealers who make a suitability determination (not discount brokers)

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series A units of the fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other series, funds and investments that may be suitable for you at a lower cost.

1. Sales charges – The front-end sales charge option applies when you buy Series A units of the fund.

Sales charge option	What you pay		How it works

Front-end	0% to 5% of the amount you buy	\$0 to \$50 on every \$1,000 you buy	This is a front end sales charge option in which you pay a commission to your representative when you buy the units. The sales charge is deducted from the amount you invest in the fund. You negotiate the rate of commission directly with your representative, up to a maximum of 5%.

2. Fund Expenses You don't pay these expenses directly. They affect you because they reduce the fund's returns. As of December 31, 2022, the Series A expenses of the fund were 2.24% of its value. This equals \$22.40 for every \$1,000 invested.

Management expense ratio (MER) – This is the total of the fund's management fee (including the trailing commission) and operating expenses.	2.19%

More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own Series A units of the fund. It is for the services and/or advice that your representative and/or their firm provide to you.

PIMCO Canada pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment. The rate is 1.00% of the value of your investment each year. This equals \$10.00 each year for every \$1,000 invested.

3. Other Fees – You may have to pay other fees when you buy, hold, sell or switch units of the fund.

Fee	What you pay
Short-term trading fee	1% if a redemption occurs within 7 days of purchase or switch.
Switch fees	Up to 2% may be charged to you and retained by your representative.
Returned cheques	There will be a \$35 fee for Non-Sufficient Fund cheques that are returned if there are insufficient funds in your account to pay for your units.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
