Portfolio strategy

As valuations are below long-term median levels, we are emphasizing a patient approach and are focused on maintaining flexibility and liquidity in portfolios to take advantage of opportunities as they arise

We are finding value in sectors that exhibit resiliency to higher rates and non-cyclicals that may be better anchored in the event of an economic slowdown

We see credit market opportunities in companies with high barriers to entry, growth, pricing power, and asset coverage. We have a preference for financials, telecom/cable/towers, select REITs, and non-Agency mortgages. We remain cautious on industries facing greater headwinds, such as retail.

Quarter in Review

Early signs of economic weakening spark market optimism

Indications of slowing inflation and a cooling labor market led market participants to price in an accelerated path of rate cuts for 2024, prompting a broad rally across the global bond market. Risk sentiment rebounded, with the MSCI World rising 11.53%, while the dollar weakened. The Fed paused rate hikes for the third consecutive time, while the central bank's dot plot pointed to the potential for 75 bps of cuts in 2024. Global developed central banks broadly maintained hawkish stances, with both the ECB and BoE signaling that rates would remain restrictive for longer. Meanwhile, the BoJ maintained its negative interest rate policy and left its dovish guidance unchanged.

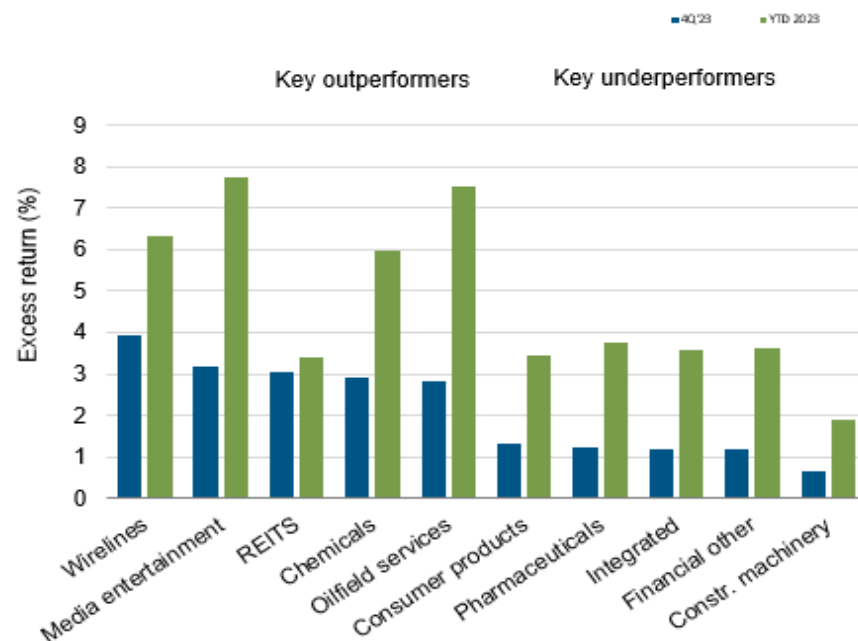
U.S. credit yields and spreads



In Q4, U.S. credit spreads tightened 19 bps to 93 bps, and the sector posted a total return of 8.15%, outperforming like-duration treasuries by 1.81%. Investment grade credit posted two strong months of returns to end the year amid the rate rally.

Credit returns were broadly positive across sectors over the quarter amid the rate rally. Following the fourth quarter rally, every credit sector posted positive returns in the full year 2023, broadly out-performing like-duration treasuries.

Market Summary

Q4'23: credit spreads tightened amid the rate rally and improving risk sentiment

The Fund's bottom-up sector and security selection contributed to performance, while duration and currency positioning also contributed.

Duration positioning

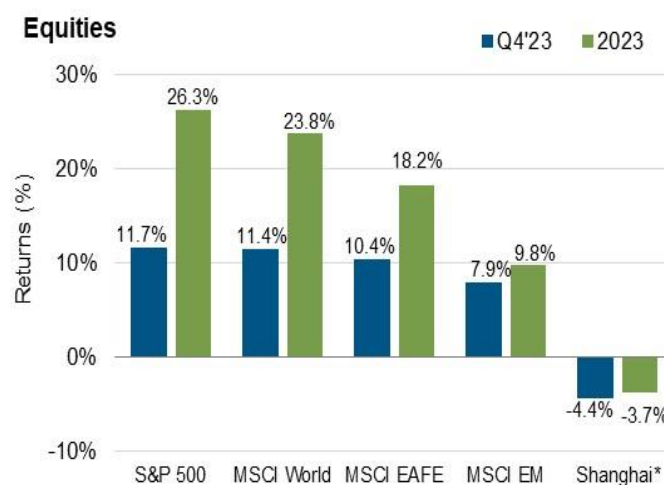
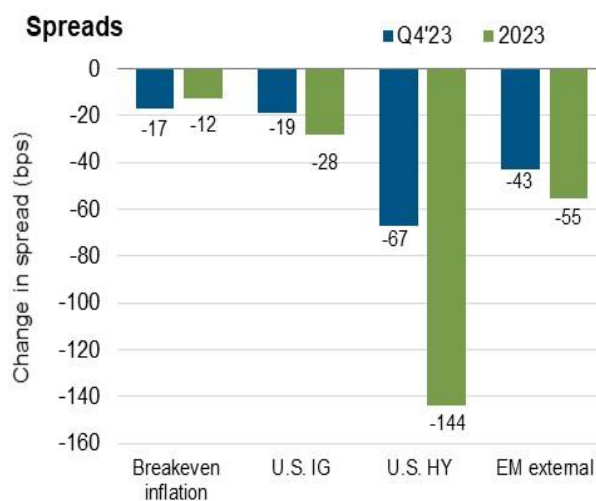
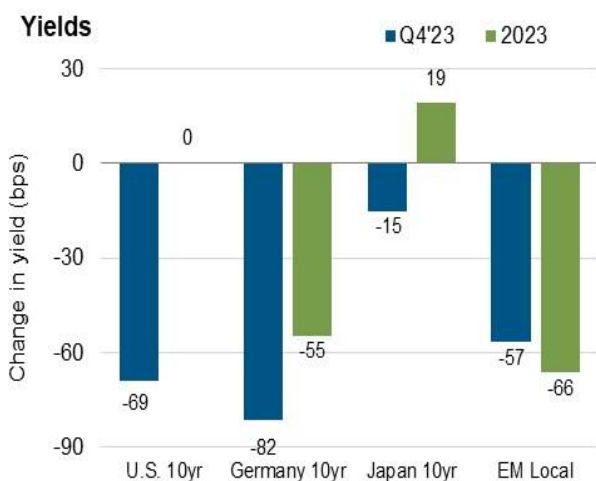
The market experienced a rate rally over the final quarter of 2023 as inflation began to slow, which has led the market to price in several rate cuts by the Fed in 2024.

Gaming

The gaming sector is supported by the continued COVID re-opening trajectory with secular growth in visitation and a rising Chinese middle class benefitting Macau gaming and a strong events calendar and pent-up demand benefitting Las Vegas gaming, slightly offset by rising macro uncertainty.

Transportation

Domestic leisure travel has surpassed pre-COVID levels and is beginning to moderate, while corporate and international travel still has room to improve with headwinds including jet fuel price volatility, higher labor costs, and geopolitical conflicts.

Portfolio Outlook

Strategic Outlook

Further disinflation and the potential for a faster cutting cycle should, in our view, raise the prospects for a soft landing. However, this is not to say that we believe that the path toward a soft landing is the only possible path. It is our view that the tighter-for-longer strategy that central banks have been communicating along with the strong possibility of stagnation in developed market supply and demand growth leave recession risks elevated.

Credit market technicals are mixed as demand remains sensitive amid rate and macro volatility but is expected to pick up at higher yield levels. Valuations are below long term median levels which warrants a patient approach and focus on maintaining liquidity and flexibility in portfolios, capitalizing on opportunities as they present themselves.

We continue to seek out high conviction opportunities, with a preference for sectors that have historically been more resilient to higher rates and non-cyclical sectors that may be better anchored in an economic slowdown. Our bottom-up positioning emphasizes companies with high barriers to entry, pricing power, asset coverage, and management teams that favor bondholders in the capital structure.

Key strategies

Non-cyclicals

We are finding opportunities in non-cyclical sectors, such as utilities, that may be better anchored during an economic slowdown.

Banks/financials

Our focus remains on large, high quality, “national champion” banks in the US and Europe that benefit from over a decade of regulatory driven capital rebuild, balance sheet de-risking, and deleveraging. We favor senior bonds issued by strong banks given attractive risk-adjusted valuations due to repricing in the sector across the capital structure.

Housing-related sectors

The Fund maintains exposure to industries tied to housing, specifically building materials, and non-Agency MBS where fundamentals remain strong with higher homeowner equity.

Retail

We are less constructive on retail, which faces continued margin pressure from online competitors as well as increased input costs, weak cash flow projections, and high leverage.

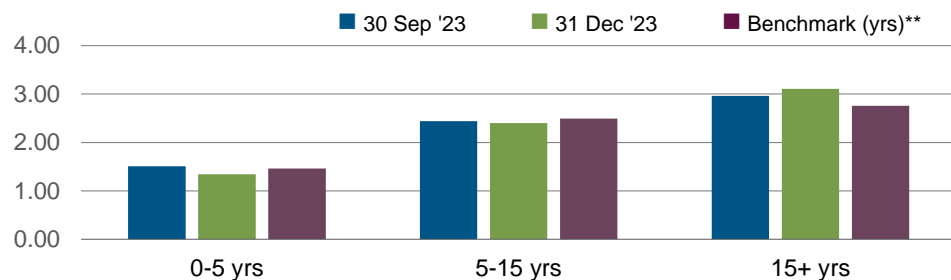

Acronyms and definitions of investment terms used throughout the report:

Alpha is a measure of performance on a risk-adjusted basis calculated by comparing the volatility (price risk) of a portfolio vs. its risk-adjusted performance to a benchmark index; the excess return relative to the benchmark is alpha.

Average coupon is the average of the coupon payments of the underlying bonds within the portfolio.

Average effective maturity is a weighted average of all the maturities of the bonds in a portfolio, computed by weighting each bond's effective maturity by the market value of the security.

"Bend-but-not-break" refers to credits that PIMCO would not expect to default in a credit-stressed environment.

Beta is a measure of price sensitivity to market movements. Market beta is 1.

Breakeven inflation rate (or expectation) is a market-based measure of expected inflation or the difference between the yield of a nominal and an inflation-linked bond of the same maturity.

Carry is the rate of interest earned by holding the respective securities.

A security's OAS is the average return an investor will earn over Treasury returns, taking all possible future interest rate scenarios into account. The OAS is the net spread over the swap curve that will on average be earned if the security is held to maturity.

Rising star is the term given to a bond that was rated high yield but has since been upgraded to investment grade.

"Risk assets" are any financial security or instrument that are likely to fluctuate in price.

Risk premia is the return in excess of the risk-free rate of return an investment is expected to yield.

Roll yield is the yield that a futures investor captures as their long position in a futures contract converges to the spot price.

The **SEC yield** is an annualized yield based on the most recent 30 day period. The subsidized yield includes contractual expense reimbursements and it would be lower without those reimbursements. The

Unsubsidized 30 day SEC Yield excludes contractual expense reimbursements.

Tracking error measures the dispersion or volatility of excess returns relative to a benchmark.

To relate the price sensitivity of ILBs to changes in nominal yields, yield beta is applied to nominal changes to arrive at a price sensitivity of ILBs to changes in nominal rates. A **yield beta** of 0.90 implies that if nominal yields move 100 basis points, real yields will move 90 basis points. ILBs with long maturity may respond differently to changes in nominal rates than shorter maturity ILBs.

The distribution yield for monthly paying Funds is calculated by annualizing actual dividends distributed for the monthly period ended on the date shown and dividing by the net asset value on the last business day for the same period. The distribution yield for quarterly paying Funds is calculated by taking the average of the prior four quarterly distribution yields. The quarterly distribution yields are calculated by annualizing actual dividends distributed for the quarterly period ended on the most recent quarterly distribution date and dividing by the net asset value for the same date. The yield does not include long- or short-term capital gains distributions.
