


PIMCO Monthly Income Fund (Canada)

- Pursues income across global fixed income sectors The global economic landscape is
 constantly changing, causing different bond sectors to go in and out of favour. The fund's
 multi-sector approach allows it to seek out the best income-generating ideas in any market
 climate, targeting multiple sources of income from a global opportunity set.
- Total return approach to maximizing income potential While maximizing current income is
 its primary goal, the fund also maintains a total return focus, meaning capital preservation
 and appreciation remain critical goals. Rather than pursue only the highest income streams
 from potentially risky securities, the fund seeks high and consistent income from diversified
 sources.
- Ability to be opportunistic The fund can tactically shift portfolio weightings, moving to
 wherever we believe attractive yields can be generated in this increasingly complex and
 volatile investment environment. This flexibility helps the fund to nimbly capture opportunities
 as economic and market conditions change.

Duration is a measure of a portfolio's price sensitivity expressed in years.

The Sharpe Ratio measures the risk-adjusted performance. The risk-free rate is subtracted from the rate of return for a portfolio and the result is divided by the standard deviation of the portfolio returns

Volatility is measured by the standard deviation, or dispersion of a set of data from its mean, based on historical portfolio returns. A larger spread of data indicates higher standard deviation and higher volatility.

Effective maturity is a weighted average of all the maturities of the bonds in a portfolio, computed by weighting each bonds effective maturity by the market value of the security.

Bloomberg U.S. Aggregate Index (CAD Hedged) represents securities that are SEC-registered, taxable, and dollar denominated. The index covers the U.S. investment grade fixed rate bond market, with index components for government and corporate securities, mortgage pass-through securities, and asset-backed securities.
