

PIMCO Canadian Total Return Bond Fund

PERFORMANCE SUMMARY

The PIMCO Canadian Total Return Bond Fund returned 0.68% after fees in March, outperforming the FTSE Canada Universe Bond Index by 0.19%. Year-to-date the Fund has returned -0.79% after fees.

Mar'24: Canadian and other developed market sovereign bond yields fell as central banks sent dovish signals to the market. Canadian inflation data continued to print better than expected results, with the February CPI figure within the Bank of Canada's 1-3 percent target for the second month in a row. In the period, Canadian credit spreads did not exhibit meaningful movements, while U.S. credit spreads tightened.

PORTFOLIO POSITIONING

Strategies we expect to pursue include:

Interest Rate Strategies – We seek to be dynamic with our duration exposure, seeing relative value opportunities between Canadian and U.S. rates while running a neutral to modestly overweight profile to overall benchmark duration.

Credit – We are cautious on generic credit and believe that the recent tightening in credit spreads reduces opportunity and has an asymmetric potential for spreads to widen further. Instead, we believe we can find better opportunities within securitized fixed income, senior global financials, and provincials which offer attractive yields given their level of risk.

Non-Canadian Markets and Currency – We seek tactical opportunities that provide attractive risk-reward profiles and the ability to diversify sources of return. We are tactically overweight USD and select emerging market Latin American currencies given their strong technical and fundamental characteristics.

MONTH IN REVIEW

The Canadian 2-year fell by 6 bps to end the month at 4.06 percent while the 10-year yield fell by 5 bps to 3.46 percent. Meanwhile, the Canadian 30-year yield fell by 3 bps to end the month at 3.35 percent.

The FTSE Canada Universe Bond Index returned 0.49 percent overall. Government of Canada and corporate bonds outperformed the index by returning 0.51 percent and 0.54 percent respectively, while provincials underperformed the index returning 0.43 percent.

OUTLOOK AND STRATEGY

We do not see value in taking excessive interest rate risk. We will seek to be neutral to slightly overweight with yields at their current levels.

We favour high quality corporate and U.S. securitized credit, and continue to have high conviction in high quality opportunities in global financials in the senior capital structure. We are also adding exposure to Canadian provincials which exhibit attractive spreads relative to their fundamental risk profiles.

PIMCO will seek to maintain duration and tactical currency exposure to countries that have strong fundamentals and offer the potential for higher yield and diversification.

The **Sharpe Ratio** measures the risk-adjusted performance. The risk-free rate is subtracted from the rate of return for a portfolio and the result is divided by the standard deviation of the portfolio returns.

Volatility is measured by the standard deviation, or dispersion of a set of data from its mean, based on historical portfolio returns. A larger spread of data indicates higher standard deviation and higher volatility.
